It has been doing pioneering research with a focus on development and change. The Institute invites applications for the post of Director from suitable persons who have attained a place of eminence in the field of Social Sciences and capable of providing academic leadership, for the consideration of the Selection Committee.

ESSENTIAL QUALIFICATION

- 1. High Second Class M.A. or equivalent degree from a Foreign University.**
- 2. Doctorate Degree or publications of a high order.**
- 3. Seven years experience of guiding Research.**
- 4. Experience of guiding Research.**

No person shall be deemed to be qualified to hold the office of the Director, unless he is a person who has attained a place of eminence in the field of social sciences and capable of providing academic leadership. The maximum upper age is 70 years for this post. The Director will be appointed for an initial term period of three years extendable by another term subject to the age cap. The extension will be strictly based on performance and subject to approval by the Board of Control from the date on which he/she assume charges of his/her office. No Director can hold office after 70 years of age. The term will come to an end on the date of completion of 3/6 years as the case may be or on the date that the incumbent attains the age of 70 years, whichever is earlier. The pay of the Director shall be equivalent to the Vice-Chancellor of a university established under the act of the legislature of the State of Bihar. Other facilities and allowances will be applicable as per the regulations of the Institute.
