The Institute invites applications for the post of Director from suitable persons who have attained a place of eminence in the field of Social Sciences and capable of providing academic leadership, for the consideration of the Selection Committee.

ESSENTIAL QUALIFICATION

- 1. High Second Class M.A. or equivalent degree from a Foreign University.**
- 2. Doctorate Degree or publications of a high order.**
- 3. Seven years experience of guiding Research.**
- 4. Experience of guiding Research.**

No person shall be deemed to be qualified to hold the office of the Director, unless he is a person who has attained a place of eminence in the field of social sciences and capable of providing academic leadership. Selected candidate shall hold the office for a term of three years from the date on which he/she assumes charges of his/her office and on expiry of the said term, he/she may be reappointed for another term not exceeding three years. No Director can hold office for more than six years in all. The pay of the Director shall be equivalent to the Vice-Chancellor of a university established under the act of the legislature of the State of Bihar. Other allowances will be payable as per regulation of the Institute. The age of the superannuation is 65 years as per BOC Decision.
